HOW TO STOP THE FUNDING CALLS FOR GOOD

Your step-by-step guide to silencing broker solicitations, registering on the Do Not Call list, and taking back control of your phone, your inbox, and your time.

If you've ever filled out a single online form asking about business funding, you already know what comes next — your phone doesn't stop. Calls at 7am, texts at 9pm, emails flooding your inbox from companies you've never heard of, all promising you the best deal in the market. None of them know your business. None of them have your best interest in mind. And none of them are going away on their own.

The truth is, when you submit your information online, it often gets sold to lead aggregators who then sell it to dozens — sometimes hundreds — of brokers simultaneously. You become a commodity. This guide gives you the exact tools to shut it down.

STEP 01

Register on the National Do Not Call Registry

The FTC's Do Not Call Registry is the first and most important step. Once registered, telemarketers are legally prohibited from calling your number. It takes less than two minutes and is completely free. Your registration never expires.

Visit the official FTC registry site. Enter your phone number and email to confirm. Registration takes effect within 31 days. After that, unsolicited sales calls become illegal — and you can report violations directly on the same site.

STEP 02

Reply STOP to Every Unwanted Text

Under the Telephone Consumer Protection Act (TCPA), any company sending you marketing texts is legally required to honor an opt-out request immediately. The word STOP is the universal signal — and it works.

What to do	What it does
Reply STOP	Legally required opt-out — they must remove you
Reply UNSUBSCRIBE	Works with most email and SMS systems
Reply CANCEL	Alternative opt-out word recognized by TCPA
Reply NO	Accepted by many platforms as an opt-out signal

STEP 03

Report Violations to the FTC

If calls continue after you've registered on the DNC list, or if a company ignores your STOP request, you have the right to report them. The FTC takes these complaints seriously and uses them to build cases against repeat violators. You may even be entitled to compensation under the TCPA.

STEP 04

Use Call Blocking Tools on Your Phone

While the legal routes work over time, call blocking gives you immediate relief. Most modern smartphones have built-in tools — and there are powerful free apps that go even further.

Tool	Platform	What It Does
Silence Unknown Callers	iPhone (iOS)	Sends all unknown numbers directly to voicemail
Filter Spam Calls	Android	Built-in spam detection and call screening
Nomorobo	iOS & Android	Intercepts robocalls before your phone rings
Hiya	iOS & Android	Identifies and blocks spam callers automatically
RoboKiller	iOS & Android	Blocks and answers spam calls with AI

STEP 05

Stop Filling Out Generic Online Forms

This is the root cause that most people overlook. The moment you submit your information through a generic "get a business loan" form online, that data is typically sold to a lead aggregator who distributes it to anywhere from 10 to 100+ brokers. Your information becomes a product.
